### 11.1 Information on toxicological effects

Velsicol Chemical LLC has not conducted toxicity tests on VELSIFLEX<sup>®</sup> 314. However, toxicity data are available on the components of this material.

# **Acute toxicity**

This material is not classified as acute toxic for all exposure route listed above.

The acute median lethal oral doses (LD50) to male and female rats were calculated to be: 4843 mg/kg bodyweight (males), 3535 mg/kg bodyweight (females), and 4190 mg/kg bodyweight (both sexes).

No deaths were seen in rats exposed to a 200 mg/L atmosphere in air for four hours.

The acute lethal dermal dose to rats was demonstrated to be greater than 2000 mg/kg body weight.

#### Skin corrosion/irritation

It is not irritating to the skin and are not considered to be a primary skin irritant.

DEGDB did not produce evidence of skin sensitization (delayed contact hypersensitivity) in any of the animals tested.

A dietary concentration of diethylene glycol dibenzoate (DEGDB) at 10000 ppm should be considered as the No Observed Adverse Effect Level (NOAEL) for parent animals. The NOAEL for the developing offspring is considered to be 3300 ppm. The No Observed Effect Level (NOEL) for reproductive parameters is considered to be 10000 ppm.
